#### Creating a Positive Experience at the Harper County Fair

County fairs are community get-togethers that provide great opportunities for teaching youth responsibilities and decision- making skills. It also provides an opportunity for the general public to learn and gain a new respect for the many projects exhibited. It is an exciting and fun time of the year.

Let us remember that exhibiting at the county fair is a learning experience for everyone. The learning comes from the entire experience from practicing and preparation of the exhibit at home, to showing the exhibit at the fair -not just the first place ribbon.

The judging process is a vital part of the county fair educational experience and the evaluation of an exhibit should be positive.

Exhibiting good sportsmanship is not just for youth, it applies to all exhibitors, parents, grandparents, volunteers, teen leaders, fair supporters, spectators and everyone involved.

Teach your child sportsmanship. Require him/her to demonstrate sportsmanship before, during and following competitive activities.

Encourage them to:

- Learn and follow rules, be honest, fair, and straightforward in everything they say and do
- Be well mannered and show respect treat people, animals and things kindly
- Refrain from ill humor and arguing
- Respect and accept judges final decision and the results with a positive attitude.
- Congratulate winners! Applaud for your children, your friends' children, your club members, and others to express appreciation and admiration.

**Purple Ribbon** Superior quality. Usually reserved for top two or three of the group, but not limited in number given.

**Blue Ribbon** Excellent quality. Exhibit most nearly meets the standard (does not indicate perfection).

**Red Ribbon** Good; relative to pre-established standards, a few specific shortcomings have been identified.

White Ribbon Below average quality. Does not meet standards. Improvement needed.

**Participation Ribbons** are given when members exhibit for personal satisfaction, not to see how their exhibit compares to a standard.

#### **DUTIES OF FAIR SUPERINTENDENTS**

Read and be familiar with all General Rules concerning the County Fair and special rules for your department.

The following are specific duties of all superintendents:

- 1. Be present for "Clean-Up" the Monday before fair at 7:00 p.m. to get your department setup and ready.
- 2. <u>On entry day of the fair, be present to accept exhibits</u> <u>in your department.</u>
- 3. Arrange exhibits in proper place.
- 4. Assist the judge during the judging of the exhibits. Answer the judges' questions, but do not converse with the judges about the exhibits.
- 5. Place ribbons and entry cards on the exhibits. These are available from the Fair Secretary. Please copy premium amount onto entry cards before turning into the fair secretary.
- 6. Use your superintendent copy from the entry card to prepare news release of results for the newspaper; include class name, participant, ribbon or special awards.
- 7. When you have completed putting premiums amounts on entry cards, return premium copy to the fair office along with unused supplies.
- 8. Superintendents and assistants should supervise their department daily and keep it clean and neat.
- 9. When new questions come up where we have no policies, please make suggestions and clear the question with your committee and/or the Fair Board.
- 10. In case something comes up and you are unable to serve, please notify the fair secretary and try to have someone in mind.

#### **Inside Spaces:**

Inside spaces are \$40 each. Inside spaces are for nonconcession vendors only. Spaces are approx. 10' x 10'. If needing a larger space, please pay for the number of 10' x 10 spaces that you would like, and you will be assigned adjoining spaces.

#### Spaces Outside the Blue Barn:

Outside spaces near the 4-H and open class exhibit building (Blue Barn) are \$80 each. Outside spaces do not have a set size. We will do our best to accommodate you. The number of these spaces will be limited by space. These spaces are for non-concession vendors only.

#### Space in the park for Concession and Food Truck vendors:

Concession vendors (selling food for immediate consumption) will be located in the park at the corner of 10th and Central. The cost will be \$150 for concession vendors. Space and electricity in this location are limited and will be assigned on a first-come basis.

#### **Rules and Regulations:**

- 1. No space is reserved until the commercial booth superintendent receives the fee and entry form.
- 2. The deadline to request a commercial booth is August 1.
- 3. Booth locations will be assigned prior to the fair by the commercial booth superintendent on a first-come, first-served basis.
- 4. The superintendent may not be able to ensure that each commercial booth is unique. If you would like to know if a booth selling similar items to yours has been rented, please ask.
- 5. Table and chairs are provided on a first-come basis.
  Please plan accordingly, as there may not be enough for everyone.
- 6. Set-up may take place beginning at 4:00 pm on Wednesday, August 10.
- 7. The exhibit building is open 8:00 am to 10:00 pm, Thursday through Saturday.
- 8. Commercial concession vendors (those that sell food for immediate consumption) will be located in the park. See above.
- 9. Any vendor that is selling or preparing potentially hazardous (food that requires cold or hot holding) may be subject to inspection by the Kansas Department of Agriculture.
- 10. Any vendor handling food must make use of proper sanitation and hand-washing practices.
- 11. While every precaution will be taken to prevent loss or damage, the fair is not responsible should any occur.
- 12. The fair board reserves the right to ask vendors to remove items that it deems objectionable for any reason. If the vendor does not comply, they will be asked to leave and forfeit the rental fee.
- 13. Booths must remain in place until 8 pm on Saturday

#### **Open Class General Rules**

- 1. Pre-entry forms can be obtained from the extension office prior to the fair, or during entry time at the fair office in the Northeast corner of the fair building
  - Most open class premium checks will be ready after the parade on Saturday at 8:30 pm.
- 2. No animal or article shall be assigned a place until entry has been made with the department superintendent.
- 3. The superintendents shall have complete charge of their respective departments and shall have the power to arrange exhibits and allot space as they see fit and determine the proper class for each entry.
- 4. No exhibit, whether having competed or not, shall be awarded a premium unless it possesses merit. In case there is only one entry in a class, the judge will decide as to its merit. In open class departments, there will be only 3 ribbons given in each class: 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> place ribbons.
- 5. No exhibitor shall receive more than two prizes in the same class or open group classes.
- 6. No exhibits shall be publicly advertised for sale. Any violation will result in the ribbon being taken and the premium money forfeited.
- 7. The fair management will pay premiums as listed in the book. Additional premiums may be paid by outside interests, but are not guaranteed by the fair.
- 8. No article or exhibit shall be removed from the fairgrounds before 8:00 p.m. on Saturday and must be removed by the following day of the fair unless by special permission from the superintendent of the department. Failure to abide by this rule shall cause the exhibitor to forfeit prize money.
- 9. The fair management will observe reasonable precautions to avoid accidents, injuries, or losses should they occur.

#### **Special Livestock Rules**

See also special 4-H/FFA Livestock Rules pg. 50 & 51.

- 1. There will be no vehicle access in the alley between the livestock barns and the red barn after weigh-in is complete, Wednesday-Saturday, 8:00 p.m.
- 2. Swine must check in between 5:00 9:00 p.m. on Tuesday evening. All other livestock entries must check in Wed., at their designated times.
- 3. To be eligible to compete for prizes, every animal must be accepted for record in its respective breed herd book, except where grades are designated.
- 4. Every animal competing for prizes must be owned by the exhibitor and entered accordingly.
- 5. Stall space will be assigned by the fair superintendent.
- 6. The use of straw is prohibited due to dust, allergies, and the fire hazard that is present.
- 7. Fair Association **WILL NOT** be providing bedding chips for swine, sheep, & goats. Exhibitor needs to supply their own chips for bedding.

#### Health Requirements

- All livestock may be subject to inspection by a licensed veterinarian at the time of unloading.
  - All animals showing symptoms of a contagious or infectious disease will be promptly excluded from the fairgrounds.
- Livestock originating in other states must meet the Kansas import requirements.
  - These exhibitors should have two copies of their health certificates, leaving one copy at the Kansas Port of Entry and taking one copy to the fair.
- Exhibitors have a serious responsibility to use animal health aids (drugs), growth promoters, and any other approved materials with great care, only when needed, and in the correct amounts. The giving of any product not approved for any domestic animal constitutes an unethical practice.
- The Harper County Fair Board reserves the right to have blood or urine analysis made on any animal entered for competition.
  - Misuse of unapproved medication or other materials will result in the exhibitor forfeiting all prizes and premiums.

- Official crop data cards and sample bags provided by the Harper County Extension Office. The card must be completed prior to entry.
- All samples become the property of the show committee.
- Samples must be taken from truckloads delivered to the grain elevator or from the farm bin by an elevator representative. Samples hand-carried into the Extension Office will be disqualified.
- All exhibits shall be combine run only. Any entry that has been hand-picked and/or screened will be disqualified.

#### GENERAL RULES

- 1. Open to bona fide members of 4-H Clubs and FFA in Harper County, enrolled by January 1st.
- 2.4-H members must be enrolled in the project area where they will be exhibiting by May 1st.
- 3. ALL Pre-entries are due July 15 using the FairEntry system.
- 4. Prize money will be awarded to static exhibits.
  Blue \$1.00, Red \$.75, White \$.50
  Unless otherwise noted in the book.
- 5. Projects are judged by the Danish Ribbon System. Champion and Reserve Champion ribbons will be selected from the blue ribbon group.
- 6. State 4-H and FFA guidelines will apply in cases not covered by the above rules. Certain exceptions may apply, but must be approved by State 4-H or FFA and be in writing and on file in the Extension Office.
- 7. The superintendent shall have complete charge of their department in respect to arranging exhibits and allotting space as they see fit, and determining the proper class for each entry.
- 8. Harper County Extension Council & Harper County Fair Board reserve the right to remove from the grounds any exhibitor, animal, or person that may be deemed objectionable, unmanageable, or misused. The superintendent has the final say.

#### STATIC EXHIBITS

- 1. All exhibits must be the result of the current club projects and products of the exhibitor's efforts.
- 2. Exhibits allowed per 4-Her
  - Six per department and two per class.
- 3. Booths must be in place by 9:00 p.m. on Wednesday.
- 4. All static exhibits check in at the judging time.

#### LIVESTOCK EXHIBITS

- 1. Check your livestock species for check-in time.
- 2. Except for large livestock (see livestock rules), all exhibits are to remain in place until Saturday, 8:00 p.m.



#### LIVESTOCK RULES

- 1. Family/Household Livestock Declaration. Youth will be allowed to enter and show any animal that was tagged by their household according to the following restrictions. Sheep exhibitors reference Sheep Dept Manual. The youth entering the animal must have physically participated in the care of the project for the majority of the time.
- 2. Exhibitors must designate whether they are showing 4-H or FFA at time of tagging.
- 3. Livestock PRE-ENTRIES are DUE in the Extension Office NO LATER THAN JULY 15.
- 4. All 4-H/FFA market animals shown at the county fair must have an official 4-H ear tag on record in the Extension Office (90 days for swine, sheep and goats, and 150 days for beef) before fair or animals cannot be shown. All livestock, breeding and market, must be owned by exhibitor. Official breed determination will be made at entry time. All market animals must be castrated and healed.
- 5. All livestock will be shown by the pre-entered showman unless they are exhibiting two animals in the same class. Person helping must be a Harper County 4-H/FFA member and approved by the superintendent.
- 6. In showmanship, the animal being used must be the exhibitor's project and the same animal must be used throughout the showmanship competitions.
- 7. Any special circumstances or grievances before and during fair must be presented in writing and presented to the grievance committee. The grievance committee's decision is final. The grievance committee shall include all the superintendents of each livestock species, the County Extension Agent and FFA Instructors.
- 8. Superintendents must be present at the time of weigh-in or re-weigh for weight to be official.
- 9.4-H member may receive assistance from a Harper County 4-H/FFA member, or immediate family, for grooming and in show preparation. 4-H/FFA member must be present and taking an active part in the process. Adult guidance instruction is encouraged and should be limited. After the 1<sup>st</sup> warning, violation of this rule will disqualify an exhibitor.
- 10. Ribbon and premium sale money will be withheld if livestock exhibitors fail to clean up their pens by 11:00 a.m. on Sunday afternoon after the fair.
- 11. It is optional to floor or market your beef, sheep or goat as long as your intentions are stated by the owner or representative at the time of weigh in to the superintendent, with the understanding that the decision is final.
- 12. The use of straw, hay, or alfalfa is prohibited due to dust, allergies, and the fire hazard that it presents. Fair Association WILL NOT be providing bedding chips for swine, sheep, & goats. Exhibitor needs to supply own chips for bedding.
- 13. Beef, sheep and goat owners assume all responsibility for ensuring their animals aren't loaded on the truck, if those animals have been listed to go home.
- 14. The superintendent shall have complete charge of their department. Classes will be determined upon completion of weigh-in. Show management reserves the right to combine or add classes as they see fit.

#### LIVESTOCK RULES CONTINUED

16. There will be no vehicle access in alley between livestock barns and red barn after weigh in is complete Wednesday - Saturday at 8:00 p.m.

#### ANIMAL LOAD OUT

All livestock shall remain in place until 8:00 p.m. Saturday. Any livestock being sold to the floor buyer may leave the grounds early with the floor buyer, at the discretion of the Superintendent.

Animals on lead **may** be loaded out after 8:00 p.m. on Saturday **NORTH** of the Blue Barn **ONLY**!

- Load out time for livestock is Sunday 8:00-11:00 a.m.
- Swine will **ONLY** load out Sunday from 8:00-11:00 a.m.
- Sheep will **ONLY** load out Sunday from 8:00-11:00 a.m.

All stalls must be cleaned out by 11:00 a.m. Sunday.

SALE ORDER: Sheep, Swine, Goats, Beef, white, red, blue

- 1. Notice to exhibitors: it is your responsibility to mark at the conclusion of each show which animal you would like to be in the premium auction. If not marked, WE WILL NOT BE HELD RESPONSIBLE for you not having an animal listed for the auction.
- 2. Beef, sheep & goats need to be marked with either sale, floor, or home. All swine will be going home.
- 3. All animals sold must be sold under the same name as exhibited in the show.
- 4. All animals must meet minimum weight requirements to be in sale, 230 lbs. on swine, 100 lbs. on lambs, 1050 lbs. on beef, 60 lbs. on meat goats.
- 5. Only one animal can be sold per person.
- 6. An animal can be removed from the sale up until the time it enters the sale ring.
- 7. A premium buyer **does not** have the option to take an animal home.
- 8. All transactions are to be paid on the day of the sale.
- 9. Each seller must present to the Extension Office a stamped thank you card for the buyer of their animal and to plaque sponsors before receiving their premium check.

#### HERDSMAN AWARD

This award will be given out on Saturday at 1:30 pm (livestock arena). This is for cleanliness, orderly display, and the general appearance of their exhibit. Work should be done with little, if any, assistance from parents or leaders.

- 1. Read the GENERAL RULES & LIVESTOCK RULES and the Sheep Dept Manual provided at weigh-in.
- 2. All decisions as to breed characteristics are at the discretion of the superintendent. The superintendent will determine classes. All decisions are final.
- 3. All market lambs must be slick-shorn within a week of the county fair.
- 4. Breeding ewes do not have to be slick-shorn.
- 5. Only county 4-H/FFA members are to groom their sheep.
- 6. Sheep will be weighed in from 12-1 p.m. on Wednesday.
- 7. All sheep MUST be checked by a certified veterinarian before being unloaded at weigh-in. They must be free from any contagious or infectious disease.
- 8. All sheep must be identified with an official USDA Scrapie ID tag.
- 9. Lambs must weigh 100 pounds.
- 10. Must be at least 2 lambs per breed to make a class. Less than 2 animals per breed will show in the all other breeds class. The AOB class may have fewer than 2 animals.
- 11. Animals being shown in the market classes are not eligible to show in breeding classes, and vice versa.
- 12. Market lambs have been born after Jan. 1 of the current year.
- 13. Lambs must have baby teeth at the time of fair weigh-in.
- 14. NOTE: Ages for showmanship are as of Jan. 1 of the current year.
- 15. Sheep "Rate of Gain" contest the winner of the rate-of-gain contest is determined by a daily rate of gain during 4-H/FFA member ownership.
  - To be eligible for the contest, you must have your lamb officially weighed in at the time of official tagging & weigh-in.

  - Photos must be mounted with the top edge of the print 1" below the top of the mount. The sides of the print must be an equal distance from the two sides of the mount. Improperly mounted photos will be dropped from one ribbon placement.
  - A permanent mount must be made using photographic adhesive. Remove the white border from the enlargement before mounting.
  - The 4-H Photography ID Form is available by scanning the QR code in general rules section.
  - The label must be used and mounted correctly on the bottom front of the matte board.
  - No lettering, including dates, is permitted on the front of the mount or on the photo. Only the 4-H Photography ID Form is to have lettering on it. No underlay or borders are to be used.
- DO NOT USE PROTECTIVE BAGS BEFORE JUDGING. Photos will be placed in a protective bag after being judged.

• Photographs entered must be the result of the current year's project work by the 4-H member. Photos must be taken by the 4-H Member (exhibitor).

- Judging is a conference with the 4H member, food entry, and the judge.
- Foods will be judged by age division.
- Examples besides classes in Division A are suggestions, but exhibitors are not limited to those items.
- Foods will be checked in at the time of judging.
- Recipes complete with ingredients and instructions must be attached with the entry, or the placing will be lowered by one ribbon when judged.
- Entry forms must be attached to each exhibit.
- Any baked product that can be removed from the pan should be placed on a plate, foil covered piece of cardboard, or a disposable container.
- Exhibit must be covered by clear plastic wrap or bag.
- Only the food product will be judged.
- All baked goods must be left whole and uncut. Small items, such as cookies and rolls, should be the same shape and from the same recipe. Exhibit 3 cookies, 3 muffins, 3 breadsticks, 1 loaf of bread, etc. All unfrosted cakes shall be exhibited in an upright position with the crust showing.
- To help ensure food safety, any food containing uncooked cream cheese, sour cream, whipping cream, eggs, custard fillings, frostings, flavored oils, "canned" breads, cakes in a jar, cut fresh fruit, or any food requiring refrigeration (ex., bacon) will be disqualified and not judged. Refer to K-State Research and Extension publication, 4-H 488, Food Safety Recommendations for Acceptable Fair Exhibits" to help make an informed, safe food exhibit decision.

- Decorated food items must be food items, not a decorated box.
- 7-8-year-old exhibitors are not eligible for the State Fair.
- Unless foods are marked "Not for Sale", food will be sold.

- Exhibits must be sealed in clean standard canning jars with two-piece lids. Jars must be sealed when entered. Jelly must be in ½ pint or pint jars. All other products must be in pint or quart jars.
- Each jar must be labeled with the labels placed one inch from the base of the jar (available from the Extension Office).
- Two jars are required for all classes.

- Select one or two rooms in your home or imaginary/future home (bedroom, bathroom, kitchen, etc.) to design.
- Create a basic floor plan showing:

- Articles that have been in use should be cleaned for exhibit.
- A sheet of operating instructions must be furnished for any exhibit not self-explanatory.
- Two entries per class can be made.
- The plan from which the article was constructed must be included with the article exhibited.
- Any project with missing or insufficient plans will be lowered by one ribbon placement.
- One state fair entry per member.
- Classes noted with a (\*) are state fair eligible.

#### **AEROSPACE / ROCKETRY**

- The report that accompanies the rocket must be limited to the 4-H Rocket Exhibit Information Form, which is affixed to a 10" x 13" envelope. This envelope should NOT be attached to the rocket stand or rocket.
- The information form should be signed by the exhibitor. This may be downloaded by scanning the QR code.
- Any rocket exhibit not including this completed envelope will receive a participation ribbon.
- Model rockets are generally small-to-medium-sized rockets that can be purchased at hobby stores and are built from parts similar to those found in model rocket kits.
- Each rocket must be able to stand freely by itself or be supported by a solid base, not to exceed 4-1/4" thick and 8" square. Rod materials should be sturdy and not made of flimsy materials, such as coat hangers.
- Original design rockets cannot be a modification of a pre-existing kit and must be of original design.
- Original design rockets must include detailed instructions, so that someone could construct the original designed rocket just like a kit purchased at a store. Instructions can be as many pages as needed to convey full and complete construction techniques.
- All exhibitors must comply with the NAR Model Rocket Safety Code that is in effect as of October 1st of the current 4-H year.

- Each exhibitor is required to complete the "4-H Ag Mechanics Welding Exhibit Information Form" for each exhibit, except for display boards, which is available at http://welding.engtech4ks.com/. This form must be attached to the outside of a 10" x 13" manila envelope.
- Each exhibit information packet should include the following items:
  - Bill of materials for the project with associated costs, scrap items used may be listed as having a \$0.00 cost.
  - 1 to 5 pages of photos showing work on the exhibit, preferably from a beginning state to final or completed state.
  - If appropriate schematics or working drawings relating to the creation or repair, this is not required for display boards.
  - If appropriate, operating instructions.

- All electric components of the robot must be adequately covered or concealed with a protective enclosure. Paper is NOT considered an adequate enclosure or covering for electrical components.
- Robots may be powered by an electrical, battery, • water, air, or solar source only
- · Each exhibitor is required to complete the "4-H Robotics Exhibit Information Form".
- The exhibit must include written instructions for operation (the instructions should be written as if they were to tell a grandparent or elderly person how to operate the robot), construction plans, and one to five pages of project photographs.
- For robots that can be programmed, robot programming information must be included; this information should be placed inside the 10" x 13" manila envelope.

# WOODWORKING

- The plan from which it was constructed must be with the article exhibited. The plan may be a photocopy, the actual pattern, or a scale drawing. It must be complete and accurate to the extent that a duplicate article could be built using the plan as a guide.
  - Please note: a set of step-by-step instructions is not a plan.
- Projects with missing or insufficient plans will be lowered one ribbon placing (i.e., a blue ribbon exhibit will receive a red ribbon).
- The use of materials other than wood should be kept to a minimum.
- Projects that have unsecured glass, i.e., glass shelves, glass top of a coffee table, etc., should not be brought to the fair. Glass that is secured in the project, i.e., glass front of a gun case or cabinet, etc., is permissible since it cannot be easily removed.
- Extra pieces that go with your woodworking project (i.e. bean bags to go with a cornhole set, building blocks to go with a play table, etc) SHOULD NOT be submitted with the project.

#### WOODWORKING CONT.

- The entry card, plans, and all other paperwork should be enclosed in a zip-top plastic bag with a hole punched through it and tied or otherwise secured to the project in some manner. Tape is usually not adequate to accomplish this.
- Projects made from pre-cut kits are not allowed.
- In judging woodwork articles, consideration will be given to: Workmanship, including accuracy to the plan; Design; Choice of wood; Suitability and quality of finish; and Usefulness.

# **GEOLOGY & LAPIDARY**

- The exhibit box should be 18" x 24" x 3½". Plexiglas covers are required. Boxes with glass covers WILL NOT be accepted. All specimens are to be arranged across the narrow (18") dimension of the exhibit box, making the exhibit 18" across the top and 24" deep exactly. If a box has a sliding Plexiglas cover, it must be removable from the top. Screws, locks, or other devices that would prevent judges from removing the cover should not be used.
- Geology specimens should be labeled with the number of the specimen, date collected, specimen name or description, and locality (county only) where collected.
- All specimens must be collected in the state of Kansas (only exception- see #7) during the current 4-H year, which will be allowed starting on the day after the conclusion of the State Fair.
- Specimens should be mounted in the box by proper groups: rocks, minerals, fossils. Fossils must be identified to the Phylum, Class, and Genus level (if possible, or part if Genus cannot be determined).
- All specimens must be collected by the participant (not purchased) from locations in Kansas, with the exception of Tri-State Mining Area specimens collected from these three adjacent counties: Ottawa County, OK; Newton and Jasper Counties, MO. Other out-of-state specimens will not count in the minimum number for the class, nor will they be considered in the judging.
- Lapidary Classes The lapidary will be judged on the following criteria:
- Workmanship and Content 60 points
- Presentation and Showmanship 30 points
- Accuracy of Information 10 points
- All classes are State Fair eligible.

- Exhibits in this division are open to educational displays, promotional posters, or experiential displays. Follow copyright laws as explained in the General Rules as you are preparing your exhibit. Take care to select durable materials to withstand State Fair conditions.
- The exhibit size rule will be strictly enforced. Exhibits exceeding the size guidelines will be disqualified. Maximum exhibit size for all exhibits in this division is 4'X6'. Larger exhibits will be turned away.
- Educational Display: must be the standard tri-fold board ONLY, must not exceed standard tri-fold: 3'x4' unless there is a topper that sits on top of the board and does not take up additional table space; no additional table space available for promotional brochures or display items; content not to exceed display board borders.
- Promotional Posters: must be flat and no larger than 22"x30"; content not to exceed display board borders. Exhibits may be displayed on wall.
- Notebooks: no larger than 8 <sup>1</sup>/<sub>2</sub>" x 11".
- Exhibits must not display, describe, or depict firearms or firearm components that are not allowed by the 4-H Shooting Sports National Minimum Standards.
- Exhibitors must comply with state and federal laws.
- No "live" ammunition containing propellant or explosive powders may be used in any display. An inert substitution must be used in lieu of powder and "live" ammunition; the substitution must be clearly described on the back of the poster, display, or in a notebook.
- All classes are State Fair eligible

- 1. Educational Display Must directly relate to the 4-H Shooting Sports Project
- 2. Promotional Poster Must promote 4-H Shooting Sports.
- 3. Notebook Contents pertain to some phase, results, story or information about 4-H Shooting Sports

#### WILDLIFE

- Exhibitors must comply with state and federal laws. It is illegal to possess threatened or endangered wildlife, or the feathers, nests, or eggs of non-game birds. Game birds and game animals taken legally during an open season may be used. Every wildlife on display must have a statement about how they were obtained legally. The use of live wild animals in educational exhibits is prohibited.
- Exhibits in this division are open to educational displays, promotional posters, or experiential displays. Exhibits should reflect learning in the project area. Follow copyright laws as explained in the General Rules as you are preparing your exhibit. Take care to select durable materials to withstand State Fair conditions.
- The exhibit size rule will be strictly enforced. Exhibits exceeding the size guidelines will be disqualified. Maximum exhibit size for all exhibits in this division is 4'X6'. Larger exhibits will be turned away.
- Educational Display: must be the standard tri-fold board ONLY, must not exceed standard tri-fold: 3'x4' unless there is a topper that sits on top of the board and does not take up additional table space; no additional table space available for promotional brochures or display items; content not to exceed display board borders.
- Posters: must be flat and no larger than 22"x30"; content not to exceed display board borders. Exhibits may be displayed on wall.
- Notebooks: no larger than 8 <sup>1</sup>/<sub>2</sub>" x 11".
- Exhibits must not display, describe, or depict firearms or firearm components that are not allowed by 4-H Shooting Sports National Minimum Standards.
- All classes are State Fair eligible.

- 1. Notebook Contents pertain to some phase, results, story or information about the wildlife project.
- 2. Promotional Poster Must be related to something learned in the wildlife project.
- 3. Educational Display Must be directly related to the wildlife project.

# **4-H Plant Science**

#### **4-H AGRONOMY**

General Superintendent: Mike Alldritt Supt. Assistant: Clyde Ghere Judging: Thursday, 1:00 p.m.

- Exhibits should be as mature as possible.
- Every entry must be identified by a hybrid or variety name.
- All classes calling for a gallon sample may have a 2<sup>1</sup>/<sub>2</sub> 3 inch in diameter cylinder placed in a glass gallon container to reduce the amount of grain to three quarts.
- If variety is NOT stated where requested, OR samples are not tied where requested, ribbon placing will drop one placing.
- Hay samples should be approximately 15"x12"x6". Maximum thickness of 6" and minimum of 5". Hay samples should be tied with a "T". Wrap the twine horizontally around the hay and tie, then wrap vertically and tie.
- All classes are State Fair eligible.

# ENTOMOLOGY

General Superintendent: Ryan Hall Judging: Thursday, 1:00 p.m.

- All entries should be submitted in an 18 x 24 x 3.5-inch wooden display box with a clear plastic top (such as Plexiglas). Boxes can be handmade or purchased as long as they are of the correct size.
- 4-H members may choose to use one of two taxonomies:
  - Option A: As printed in "Insects in Kansas" book
  - Option B: which follows www.bugguide.net.
- The number of orders, specimens (and families where required) must be included on both of the exhibitor's box identification labels. Only one adult insect per species can be used in the Collection Boxes and Notebook Classes, unless labeled as male or female and correctly identified.
- Arrange specimens in groups or rows parallel to the short sides of the box. Specimens are to be arranged by Order in the box, then Family where required.

# ENTOMOLOGY CONT.

- Two labels should be centered on the pin beneath each specimen. First (closest to the specimen) is the common name label, and the second label should include date/locality. The full county name and state abbreviation should be on the second label.
- The specimens should be collected by the exhibitor and should focus on Kansas insects. Insects may be collected from one county into bordering states and labeled accordingly.
- Only specimens of the class Insecta should be included.
- Specimens of soft bodied insects such as aphids, lice, termites, etc. should be exhibited in alcohol filled vials; however, the use of alcohol filled vials should be limited to only those specimens that lose their shape when pinned, since the vials pose a significant hazard to the rest of the collection if they become loose in transit.
- Any major violation of the rules will result in the exhibit being dropped one ribbon placing. Examples would include, but are not limited to: incorrect display box size, missing paperwork, feet on display boxes, no special project in notebooks, etc.
- All classes are State Fair eligible.

- 1. Beginning I Entomology Collection 50 to 125 species representing at least 7 orders.
- 2. Beginning II Entomology Collection 75 to 150 species representing at least 9 orders.
- 3. Intermediate Entomology Collection 100 to 300 species representing at least 10 orders.
- 4. Advanced Entomology Collection 150 to 450 species representing at least 12 orders.
- 5. Introductory Entomology Notebook 10 to 30 species representing at least 6 orders.
- 6. Beginning I Entomology Notebook 20 to 50 species representing at least 7 orders.
- 7. Beginning II Entomology Notebook 40 to 70 species representing at least 8 orders.
- 8. Intermediate Entomology Notebook 60 to 100 species representing at least 9 orders.
- 9. Advanced Entomology Notebook 100 to 200 species representing at least 12 orders.

#### **4-H Forestry** General Superintendent: Ryan Hall Judging: Thursday, 1:00 p.m.

- All leaf exhibits are to be mounted on 8<sup>1</sup>/<sub>2</sub>" x 11" heavy stock paper and placed in loose leaf binders. (Magnetic or adhesive filler sheets for photographic prints or sheet protectors are recommended.) Twigs and fruit collections may be exhibited in whatever manner you choose. Maximum tri fold size is 3' x 4'.
- Name, club, age, and year in project should be on front cover or in a prominent location.
- Leaves should be identified with an appropriate label located near the leaf on the same page. These labels should include (1) The proper common name as listed in the 4H334, "List of Native Kansas Forest Trees" (2) Scientific Name (Optional in 2025 and required in 2026) (3) Location (city and or county) where collected; and (4) date (day, month, year) or (month, day, year) collected.

# FORESTRY CONT.

- Divide specimens into the following two sections: Native Kansas Trees, and Non-Native Trees.
- New specimens are those specimens collected during the current 4-H year and cannot be a duplicate tree species of previously displayed specimens.
- Group specimens according to the years collected (ex. "old-previous years" and "new").
- Variations of varieties do not count as different species or specimens.
- When replacing previously displayed samples, due to degradation, improper mounting or incorrect identification, the specimen label must also be updated. Replacements do not count as new specimens. Replacements should be displayed in the "old previous" section of the display.
- If you retrieve information for your forestry exhibit, you must include a reference citation to the source.
- In all leaf collections, exhibit one complete leaf where possible. If leaf is too large, exhibit as much as possible. Sketch in reduced scale the entire leaf and illustrate where the exhibited portion is from. Note: A "leaflet" is incorrect when displayed as the complete leaf for the tree.
- All work must show originality. Leaf collections and displays should not closely resemble work done by others in the same club.
- All classes are State Fair eligible.

#### HORTICULTURE & LANDSCAPE DESIGN General Superintendent: Mike Alldritt Judging: Thursday, 1:00 p.m.

- All horticultural exhibits must be grown by the exhibitor.
- Use a sturdy disposable plate, bowl or container that will support the weight of the produce.
- A member may enter up to a total of 4 produce items.
- Members may enter multiple entries in an individual class, provided each entry is a different type of produce. Ex. Class 1 Medium Vegetable; member may enter tomatoes, peppers and cucumbers under the same class number.
- A 4-H member may enter up to 4 floral exhibits.
- Members may enter multiple entries in a single class in classes provided each flower specimen is of a different species. EX: Class 8 Annual Garden Flower, member may enter sunflowers, zinnias, and marigolds under the same class number.

# HORTICULTURE & LANDSCAPE DESIGN CONT.

- Members are encouraged to exhibit cut flowers and fresh floral arrangements in disposable containers. If a non-disposable container is used, mark it plainly with your name and county/district. The State Fair is not responsible for the loss or damage to any flower arrangements, vases, or containers.
- Containers cannot be picked up until release time on the last Sunday of the State Fair.
- All floral materials must be grown and/or collected by the exhibitors. Do not use purchased plant materials. Entries should not take over one square foot of table space.
- Potted plants are not accepted.
- All entries must be freestanding, easily moved, and not require any special equipment to display. Hanging entries are not accepted.
- All classes are State Fair eligible.

# Class #

#### **Produce Exhibits**

- Garden Display Limited to four square feet of space. The garden display must be exhibited in a tray, basket, or container that can be easily moved by the fair staff. Exhibit consisting of five different fresh vegetables. The numbers of the five types of vegetables to be exhibited are as follows:
  - Large Vegetables (One Each): Cabbage, Cantaloupe, Eggplant, Large Pumpkin, Squash, Watermelon
  - Medium Vegetables (Five Each): Beets, Carrots, Cucumbers, Decorative Gourds, Potatoes, Miniature Pumpkins, Okra, Onions, Peppers, Radishes, Sweet Potatoes, Tomatoes, Garlic or other similar-sized vegetables
  - Small Vegetables (Twelve Each): Green snap beans, wax beans, English peas, cherry and pear tomatoes, or other similar-sized vegetables
  - Small fruits (One-half pint box): Strawberries, blackberries, raspberries, or other similar-sized fruits.
  - Tree fruits (5 each): Apples, pears, peaches, or similar-sized fruits.
- 2. Small vegetable specimen plate (12) Ex: green snap beans, yellow wax beans, cherry tomatoes, other small vegetables.
- 3. Medium vegetable specimen plate (5) Ex: cucumbers, tomatoes, beets, white onions, yellow onions, red onions, bell peppers, other peppers, okra, parsnips, radishes, turnips, sweet potatoes, red potatoes, white or Russet potatoes, carrots, miniature pumpkin, decorative gourds, garlic or other medium vegetables.
- 4. Large vegetable specimen plate (1) Ex: watermelon, summer squash, winter squash, large type pumpkin, eggplant, cabbage, cantaloupe, other large vegetables.
- 5. Fresh Culinary herbs (6) ex: parsley, basil, dill, etc. Six (or a comparable quantity) of one variety of fresh herbs must be exhibited in a disposable container of water. Dried herbs are not accepted.
- 6. Small fruits (one half pint box) Ex. Strawberries, blackberries, raspberries, or other similarly sized fruits. (If other, please include the name of the fruit on entry.)
- 7. Tree fruits (plate of 5) Ex. apples, pears, peaches, or similar sized fruits.

#### Floral Exhibits

8. Annual Garden Flower, cut specimen, single

9. Perennial Garden Flower, cut specimen, single.

10. Fresh Flower Arrangement. Flower materials must be grown and/or collected by the exhibitor, not purchased.

11. Dried flower Arrangement, no fabric or plastic material allowed. Materials must be grown/collected by the exhibitor.
